Job Title: Zanjero	Reports To: Watermaster
Department: Water Delivery	

POSITION OVERVIEW

A Zanjero is responsible for delivering and monitoring client's water orders making sure each client receives the correct amount of water ordered. Reporting on order changes, gauges, maintaining canal gates, and structures free of debris on a daily basis. This job calls for ability to understand and follow basic instructions as well as handle and apply common sense to varying situations. Driving will likely be 40% of a Zanjero's workday.

ESSENTIAL DUTIES AND RESPONSIBILITIES

Receive water orders and delivery of water orders

Monitor delivery of water and order size in canal and laterals.

Receive and make calls with clients and staff for water order coordination

Keep legible records and notes daily

Inspect and maintain canals, wells, and gates (to ensure supply meets demand)

Keep grates, gates, structures, and laterals free of debris

Drop boards at checks to build up water pressure at delivery gates

Required to be on call to assist in water emergencies.

May be called to operate essential equipment as needed

Safe driving (including at night) is required at all times.

Maintain a clean driving record.

QUALIFICATIONS, SKILLS, EXPERIENCE

No past experience is required, we do on the job training.

Clean driving record

Read and write basic English

Perform and understand basic math.

DRIVING REQUIREMENTS

Operate vehicles safely and responsibly. Driving will be along paved surface streets, unimproved, gravel, or dirt canal roads. Night driving will be required. Daily vehicle inspections are required at all times while on the job. If operating equipment is necessary, it will be required to log in inspection log book.

SAFETY

An Employee must be able to understand, observe, and follow all RID and DOT safety policies and protocols while working in the District, in yards, worksites, and around mechanized equipment such as forklifts, backhoes, gradalls, water trucks, etc. Maintaining safe operations and speeds while driving is required. Employees may need to attend periodic safety meetings.

PHYSICAL DEMANDS

While performing the duties of this job, the employee is regularly required to walk, stand, stoop, kneel, crouch, crawl, use fingers, hands, and arms to include feel and reaching. Required to lift, pull, and/or move up to 50 pounds. Communicate verbally, visually, and have clear hearing. Specific vision abilities required by this job include near, far, peripheral, depth perception. *The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

WORK ENVIRONMENT

Employees are regularly exposed to moving mechanical equipment and machines, pollutants such as fumes, dust, or airborne particles. Weather conditions include heat from sun and machines, occasional rain, wind, cold/ice during winter, mud, irritants, and risk of electrical shock, and extreme noise. The work environment varies frequently in location and type, however, most always is around water
